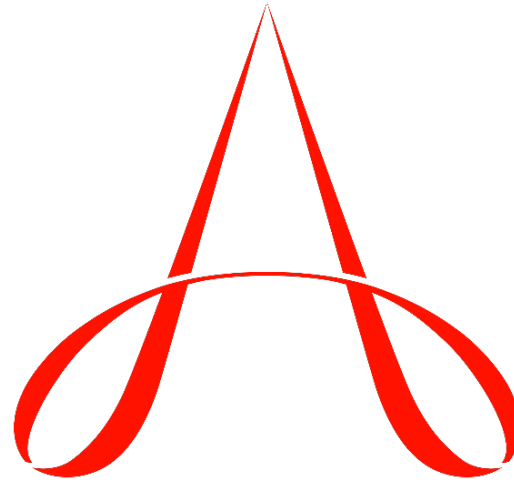

## **Milestones Supplemental Guide**

This document provides additional guidance and examples for the Urogynecology and Reconstructive Pelvic Surgery (URPS) Milestones. This is not designed to indicate any specific requirements for each level, but to provide insight into the thinking of the Milestone Work Group.

Included in this document is the intent of each Milestone and examples of what a Clinical Competency Committee (CCC) might expect to be observed/assessed at each level. Also included are suggested assessment models and tools for each subcompetency, references, and other useful information.

Review this guide with the CCC and faculty members. As the program develops a shared mental model of the Milestones, consider creating an individualized guide (Supplemental Guide Template available) with institution/program-specific examples, assessment tools used by the program, and curricular components.

<b>Patient Care 1: Patient and Pelvic Floor Evaluation</b>	
<b>Overall Intent:</b> To efficiently obtain and synthesize the history, physical exam, and collateral patient data to develop an appropriate management plan	
<b>Milestones</b>	<b>Examples</b>
<b>Level 1</b> <i>Obtains history and physical exam to form a patient assessment</i>	<ul style="list-style-type: none"> <li>● Obtains a comprehensive urogynecologic-focused history including screening for other pelvic floor disorders, documentation of previous treatments, and impact of symptoms on quality of life</li> <li>● Performs a comprehensive urogynecologic-focused physical exam including Pelvic Organ Prolapse Quantification system (POP-Q) measurements</li> <li>● Incorporates data from patient questionnaires in patient history</li> <li>● Efficiently obtains accurate and complete information from referral sources and electronic medical records to supplement patient history</li> <li>● Documents and presents patient history and physical exam accurately and completely in an organized fashion</li> </ul>
<b>Level 2</b> <i>Evaluates patients; orders and interprets diagnostic testing</i>	<ul style="list-style-type: none"> <li>● Modifies patient interview in complicated clinical situations including use of supplemental historians and translators as indicated (cognitive impairment, poor historian, language barriers, etc.)</li> <li>● Modifies physical exam to optimize data collection and patient comfort in complicated clinical situations (e.g., dementia, chronic pain conditions, poor Valsalva effort during POP-Q)</li> <li>● Obtains and interprets office urine testing (e.g., urine dipstick and/or urine microscopy)</li> <li>● Recognizes contaminated urine specimens; performs/requests catheterized specimen as needed</li> <li>● Identifies indications for imaging for evaluation of pelvic floor disorders</li> <li>● Orders and interprets computerized tomography (CT) scans, magnetic resonance imaging (MRIs), and ultrasounds</li> <li>● Identifies indications for urodynamic testing and cystoscopy</li> </ul>
<b>Level 3</b> <i>Develops a plan to manage patients with straightforward conditions</i>	<ul style="list-style-type: none"> <li>● Develops a plan for a patient with a one or more straightforward pelvic floor disorders such as overactive bladder only, pelvic organ prolapse (POP) and stress urinary incontinence, mixed urinary incontinence, or POP-Q and recurrent urinary tract infections (UTI)</li> <li>● Develops a plan that includes consideration of non-surgical and surgical treatment options</li> <li>● Develops a plan that includes consideration of patient characteristics</li> <li>● Develops a plan that includes consideration of patient treatment preferences and goals of treatment</li> <li>● Modifies plans based on interval changes in history, physical exam, patient characteristics, and response to treatment in straightforward clinical situations</li> </ul>

<p><b>Level 4</b> <i>Develops a plan to manage patients with complex conditions and adapts the plan for changing clinical situation</i></p>	<ul style="list-style-type: none"> <li>● Identifies appropriate surgical approach for a patient with recurrent vesicovaginal fistula</li> <li>● Suggests multidisciplinary collaboration for patients with neurogenic bladder dysfunction</li> <li>● Identifies and manages pelvic floor disorders overlap such as painful bladder syndrome (PBS) and overactive bladder</li> <li>● Manages recurrent symptomatic advanced prolapse with comorbidities and complicated surgical history</li> <li>● Develops plan to include consideration of inter-specialty consultation/collaboration to optimize patient outcomes</li> <li>● Negotiates goals of treatment in complicated clinical situations</li> <li>● Modifies plans based on interval changes in history, physical exam, patient characteristics, and response to treatment in complex clinical situations</li> </ul>
<p><b>Level 5</b> <i>Develops a clinical pathway for the management of patients with complex conditions or identifies clinical trials for patients</i></p>	<ul style="list-style-type: none"> <li>● Creates an algorithm for assessment and management of a patient with recurrent urinary tract infections (UTI)s</li> <li>● Institutes a systematic application of the overactive bladder guidelines</li> <li>● Refers and counsels patients with pelvic floor disorders for appropriate clinical trials, evaluating new treatments not currently available in clinical setting</li> </ul>

<b>Patient Care 2: Office-Based Procedures</b>	
<b>Overall Intent:</b> To proficiently perform all manner of office procedures encountered in independent practice	
<b>Milestones</b>	<b>Examples</b>
<b>Level 1</b> <i>Performs simple office-based procedures, with supervision</i>	<ul style="list-style-type: none"> <li>● Performs diagnostic cystoscopy</li> <li>● Prepares patient for multi-channel urodynamics including catheter insertions, electromyography patch placement, transducer calibrations, and troubleshooting</li> <li>● Initiate and complete percutaneous tibial nerve stimulation</li> <li>● Provides pessary fitting and teaching</li> </ul>
<b>Level 2</b> <i>Independently performs simple office-based procedures</i>	<ul style="list-style-type: none"> <li>● Independently performs procedures such as those listed in Level 1</li> </ul>
<b>Level 3</b> <i>Performs complex office-based procedures, with supervision</i>	<ul style="list-style-type: none"> <li>● Performs peripheral nerve evaluation</li> <li>● Performs office-based endoscopic treatments for incontinence such as intravesical Botox and urethral bulking</li> <li>● Performs urodynamics with interpretation</li> <li>● Programs and troubleshoots sacral neuromodulation system</li> <li>● Obtains images using ultrasound of pelvic floor and/or anal sphincter</li> <li>● Performs nerve injection or trigger point injections</li> </ul>
<b>Level 4</b> <i>Independently performs complex office-based procedures</i>	<ul style="list-style-type: none"> <li>● Independently performs procedures such as those listed in Level 3</li> </ul>
<b>Level 5</b> <i>Independently teaches and supervises complex office-based procedures</i>	<ul style="list-style-type: none"> <li>● Independently teaches and supervises procedures such as those listed in Level 3</li> </ul>
<b>Assessment Models or Tools</b>	<ul style="list-style-type: none"> <li>● Direct observation</li> <li>● End-of-rotation evaluation</li> <li>● Multisource feedback</li> <li>● Simulation</li> </ul>

<b>Notes or Resources</b>	<ul style="list-style-type: none"> <li>● Simple procedures: bladder instillation, diagnostic cystoscopy, multi-channel urodynamics (set-up and troubleshooting, straightforward conditions such as stress urinary incontinence (SUI) and overactive bladder (OAB)), percutaneous tibial nerve stimulation (PTNS), pessary fitting and teaching, simple cystometry, straight catheterization, suprapubic catheter change, urethral dilation</li> <li>● Complex procedures: anal sphincter ultrasound, bulking agent injection, intravesical botox, pelvic floor ultrasound, multi-channel urodynamics for neurogenic bladder, nerve injection/trigger point injection, peripheral nerve evaluation (PNE), sacral neuromodulation (SNM) interrogation and programming</li> </ul>

<b>Patient Care 3: General Peri-Operative Management (Pre-, Intra-, and Post-Procedural)</b>	
<b>Overall Intent:</b> To develop the skills for pre-operative surgical planning, to identify and manage common and more complex peri-operative/intra-operative complications, and to direct and participate in multidisciplinary surgical planning for complex cases	
<b>Milestones</b>	<b>Examples</b>
<b>Level 1</b> <i>Accurately and reliably gathers and reports clinical information pertaining to common peri-procedural risks and complications</i>	<ul style="list-style-type: none"> <li>● Reports details of gynecologic, urologic, or FPMRS prior surgical procedures</li> <li>● Practices high-quality shared decision making</li> <li>● Gives ranges of successful outcomes as well as specific procedural risks when counseling and obtaining consent</li> <li>● Comprehensively evaluates patients with multiple comorbidities and frailty status, and adjusts surgical planning in accordance with risks</li> </ul>
<b>Level 2</b> <i>Identifies alterations in normal physiology and anatomy</i>	<ul style="list-style-type: none"> <li>● Recognizes that advanced stage prolapse alters landmarks or expected locations of anatomy</li> <li>● Recognizes signs of atrophy, recommends pre-operative vaginal estrogen cream, and adjusts surgical approach/technique to minimize risk of vaginal/introital narrowing</li> <li>● Assesses vaginal length after hysterectomy and considers when determining whether sacrospinous ligament fixation is a surgical option</li> <li>● Safely restores pelvic anatomy in patients with multiple prior surgeries, mobilizes adhesions, can visualize and separate tissue planes</li> <li>● Appropriately uses pre-procedure imaging</li> </ul>
<b>Level 3</b> <i>Independently identifies and manages common peri-procedural risks and complications</i>	<ul style="list-style-type: none"> <li>● Assures appropriate equipment is available in or for the operating room</li> <li>● Communicates effectively with all team members pre-, intra-, and post-procedure to optimize physiologic stressors and response to surgery</li> <li>● Routinely avoids potential common procedural risks such as inadvertent cystotomy, excessive blood loss, wound infection</li> <li>● Manages these common complications (if occurred) with little or no guidance</li> <li>● Appropriately triages post-operative patients to emergent, immediate, or routine care, as needed</li> </ul>
<b>Level 4</b> <i>Independently identifies and manages complex peri-procedural risks and complications</i>	<ul style="list-style-type: none"> <li>● Adeptly handles massive hemorrhage from sacrum or perirectal and paravaginal spaces</li> <li>● Mobilizes appropriate consultants for organ injury</li> <li>● Minimizes further complications by recognizing surgical limits</li> </ul>
<b>Level 5</b> <i>Anticipates and implements strategies to prevent or mitigate complications, applying effective interdisciplinary team management skills to manage multiple scenarios simultaneously</i>	<ul style="list-style-type: none"> <li>● Coordinates a multispecialty care team (urology, colorectal surgery, plastic surgery, gastroenterology) for complex conditions such as recurrent rectovaginal fistula or recurrent vesicovaginal fistula</li> </ul>
<b>Assessment Models or Tools</b>	<ul style="list-style-type: none"> <li>● Direct observation/clinical evaluation</li> </ul>

<b>Patient Care 4: Endoscopic Procedures</b>	
<b>Overall Intent:</b> To perform endoscopic procedures safely and efficiently	
<b>Milestones</b>	<b>Examples</b>
<b>Level 1</b> Prepares patients and equipment for endoscopic procedures	<ul style="list-style-type: none"> <li>• Correctly assembles endoscopic equipment</li> <li>• Appropriately positions patient with pressure points padded and limbs situated ergonomically</li> <li>• Identifies appropriate bridge/scope/lens to use for specific procedures</li> </ul>
<b>Level 2</b> Performs simple endoscopic procedures	<ul style="list-style-type: none"> <li>• Anticipates additional equipment needed for procedure</li> <li>• Safely performs simple endoscopic procedures such as diagnostic cystoscopy</li> </ul>
<b>Level 3</b> Performs complex endoscopic procedures, with supervision	<ul style="list-style-type: none"> <li>• Anticipates equipment needed for different settings (outpatient versus clinic)</li> <li>• Safely performs procedures such as botulinum toxin, retrograde pyelography, urethral bulking Placement of ureteral stents, or bladder biopsy with fulguration</li> </ul>
<b>Level 4</b> Independently performs complex endoscopic procedures	<ul style="list-style-type: none"> <li>• Independently performs procedures such as those listed in Level 3</li> </ul>
<b>Level 5</b> Independently performs complex endoscopic procedures in altered anatomy	<ul style="list-style-type: none"> <li>• Identifies the impact of altered anatomy on endoscopic procedures, including hydronephrosis, duplicated collecting system, or lower urinary tract injury</li> </ul>

<b>Patient Care 5: Vaginal Procedures</b>	
<b>Overall Intent:</b> To progress from fundamental patient safety to complex surgical techniques	
<b>Milestones</b>	<b>Examples</b>
<b>Level 1</b> <i>Demonstrates basic skills (e.g., positioning, knot tying, suturing)</i>	<ul style="list-style-type: none"> <li>● Proficiently performs knot tying and suturing</li> <li>● Appropriately positions patient to provide access and avoid neurologic injury</li> <li>● Demonstrates a basic understanding of the relevant anatomy</li> </ul>
