- One ex-officio (non-voting) member each from the AAPM&R, the ABPM&R and AOA



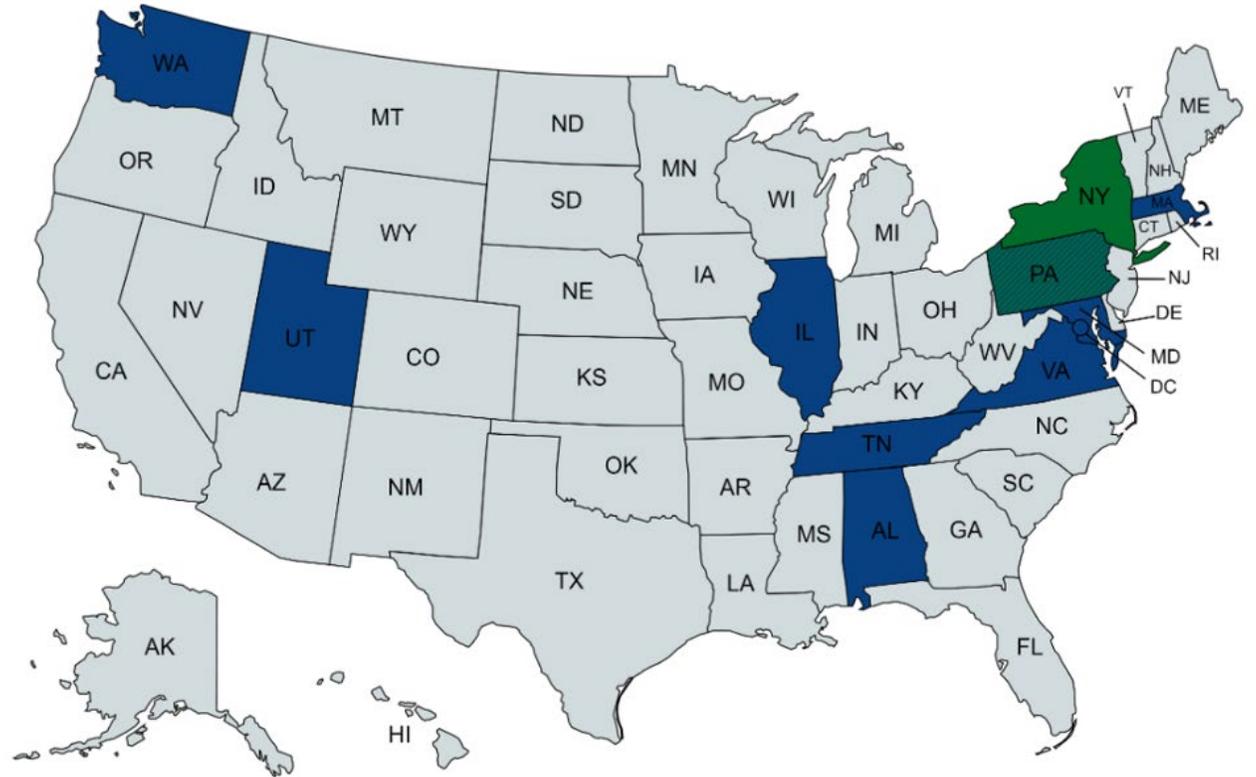

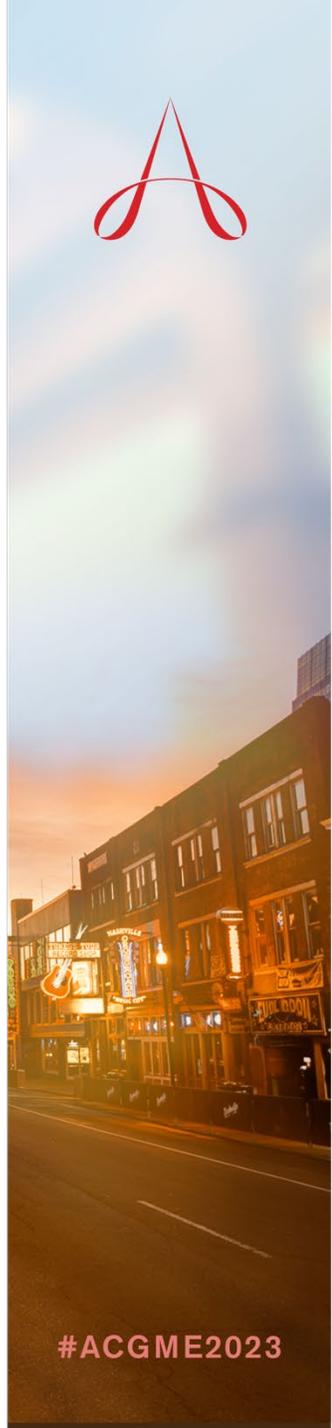

# Citations and Areas for Improvement (AFIs)

## Citations

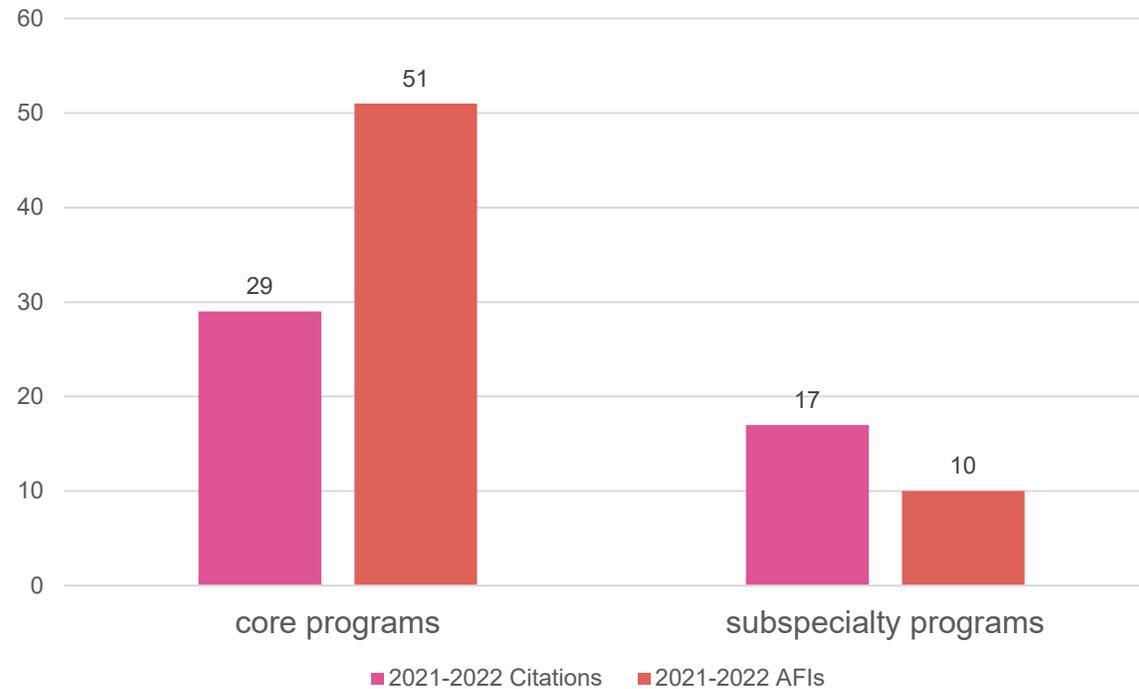
- Require a response in ADS
- Identify areas of non-compliance linked to specific program requirements
- Responses reviewed annually by the Review Committee
- Remain active until corrected
- Trend

## AFIs

- Do not require a response in ADS
- Can represent “general concerns” (but are often tied to program requirements)
- Result from annual review of program data elements
- Not automatically carried over
- First time occurrence

## *Core Programs*

### **Citations**

- Board pass rate
  - Part II
- Faculty qualifications
  - Certification | Sufficient number
- Faculty responsibilities
  - Time and interest | Professionalism
- PD dedicated time

### **AFIs**

- Procedural volume
- Failure to provide accurate/required information
- Faculty supervision and teaching
- Educational Environment
  - Overall opinion of the program

## *Subspecialty Programs*

- Faculty and fellow evaluations
  - Timely | Final and Summative Eval Language | Fellow on PEC
- Supervision
  - Levels | Guidelines for Communicating with Supervisor





# Incomplete/Inaccurate Data

- Faculty Roster | Current certification information
- Block Diagram | Key for abbreviations, non-standard format, no individual schedules, consistent with list of sites | Refer to instructions
- CVs | Current licensure, scholarly activities from last five years

- Describe the impact of the COVID-19 pandemic on your program

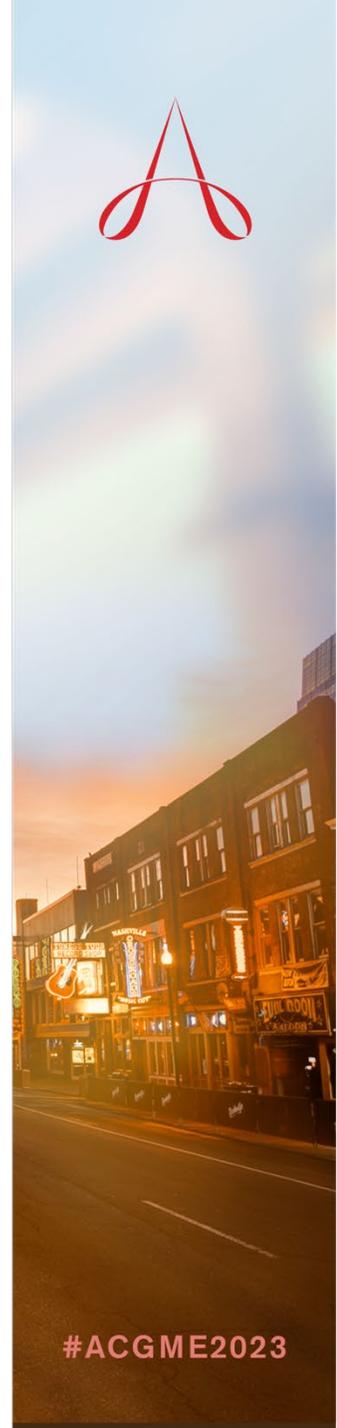

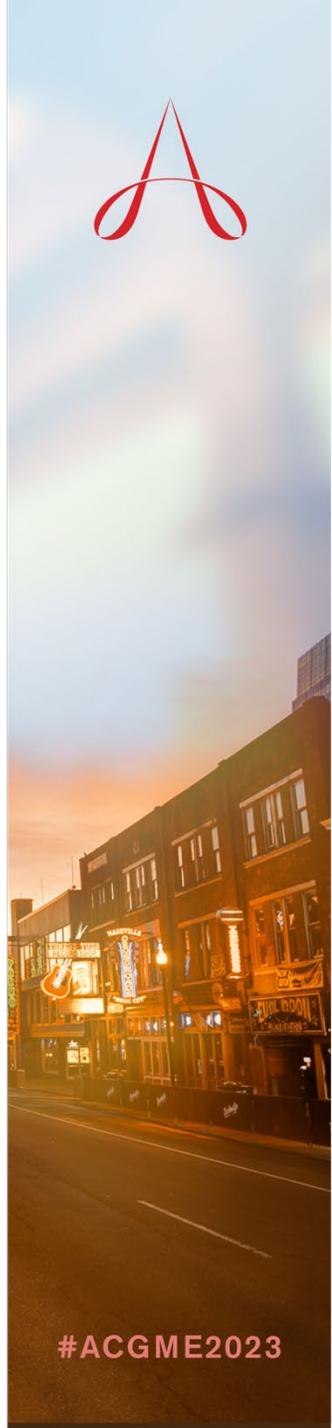
# Procedures

- Spine injections – each site counts separately
- Other injections – each limb counts separately
- Electrodiagnosis – one study per patient



# Program Director and Coordinator Support Requirements

- Programs should be provided with the required level of support based on the number of approved resident/fellow positions
- The RC-PMR will take into consideration the number of residents/fellows on duty for new programs or programs that do not routinely recruit for the number of approved positions
- Programs without trainees are still expected to have the minimum amount of program director and coordinator support





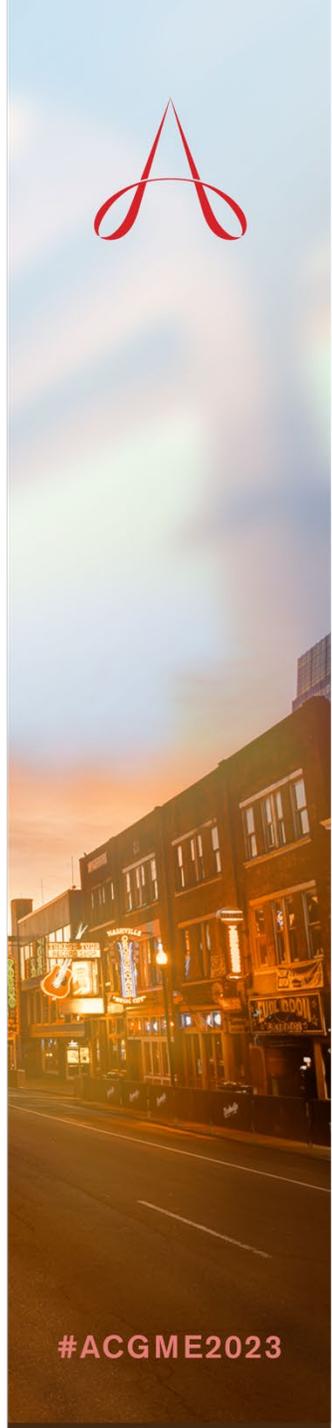
# Residency Milestones

- III.A.1.a) Fellowship programs must receive verification of each entering fellow's level of competence in the required field, upon matriculation, using ACGME, ACGME-I, or CanMEDS Milestones evaluations from the core residency program. (Core)
- This information is provided by ACGME directly to fellowship programs for graduates of ACGME-accredited residency programs

# Brain Injury Medicine Program Requirements

## *Major Revision*

- The brain injury medicine requirements are due for their 10-year revision
- A draft of proposed changes to the requirements were posted for public Review and Comment
- The final draft will be reviewed by the ACGME Board of Directors in June for approval
- The expected effective date is July 1, 2024



# PM&R Program Requirements

## *Major Revision*

- Major revision to start in early 2024
- Develop a definition of the physiatrist of the future
- Develop program requirements essential in creating the physiatrist of the future as defined





# PM&R Program Requirements

## *Scenario Planning*

- The ACGME Scenarios were created to allow participants to think rigorously and systematically about the range of uncertainties and ambiguities that we may be faced with in the future
- Presented in story fashion, scenarios are widely varied looks at the future, with each scenario offering extremely different opportunities and challenges to medicine and education
- Relied heavily on the expert judgment of participants: the scenarios provide context, participants provide the decisions
- Delivers insights and strategic ideas that are viable across a range of future conditions



# PM&R Program Requirements

## *Major Revision*

- Scenario planning workshops participants:
  - Review Committee for PM&R and ACGME Board members
  - ABPMR, AAP, AAPMR, RFPD, AOA representatives
  - Program directors to represent the breadth of programs (e.g., urban and rural, small and large)
  - Residents and fellows
  - Representatives from other Review Committees
  - Other practitioners



# PM&R Program Requirements

## *Major Revision Steps*

- Scenario planning workshop
- Data collection
  - Focus groups (patient and healthcare influencers)
  - Literature search and other data review
- Writing group develops definition of a physiatrist and strategies for Program Requirements based on workshop themes
- Comment on definition, themes and strategies
  - Public review and comment
  - Summit of invited stakeholders



# PM&R Program Requirements

## *Major Revision*

- Writing Group develops detailed Program Requirements
- Program Requirements posted for Review and Comment
- Program Requirements refined based on public feedback
- Program Requirements reviewed by the ACGME Board for approval



# Program Emergency Categorization

- Emergency categorization may now be requested for individual programs
- Requires DIO approval
- May be requested for RSV/flu/COVID-19 surges
- Can be requested in 30-day increments for up to 90 days in any given calendar year
- More information is available in the COVID-19 section of the ACGME website



# Self-Study/10-Year Accreditation Site Visit

- All program Self-Study and 10-Year Accreditation Site Visit dates were removed in the Accreditation Data System (ADS) as the ACGME finalizes future plans for site visits for programs with a status of Continued Accreditation.
- In the meantime, the ACGME encourages programs to incorporate the Self-Study into their Annual Program Evaluation process, and to track ongoing progress and program improvements as outlined in the Common Program Requirements.





# Institutional Review News

- Institutional Requirements are undergoing a major revision and will be posted for review and comment mid-year with an expected effective date of July 1, 2024
- Carceral Medicine (formerly correctional medicine) has been approved as a subspecialty area under the Institutional Review Committee



# ADS Changes

- Participating site amenities:
  - Clean and private facilities for lactation with proximity appropriate for safe patient care
  - Clean and safe refrigeration resources for the storage of human milk
