

Case Log Instructions: Regional Anesthesiology and Acute Pain Medicine Review Committee for Anesthesiology

BACKGROUND

The ACGME Case Log System helps assess the breadth and depth of the clinical experience provided to fellows by a regional anesthesiology and acute pain medicine fellowship program. It is the fellows' responsibility to enter their case data accurately and in a timely manner, and the program director's responsibility to ensure fellows' Case Logs are accurate.

While the system is open starting July 1, 2022, fellows *are not required* to log cases until the academic year beginning July 1, 2024.

The following experiences are being tracked for regional anesthesiology and acute pain medicine:

COMMON QUESTIONS

Are fellows required to enter cases into the ACGME Case Log System?

Logging cases in the ACGME Case Log System is required beginning July 1, 2024. Logging cases in the system prior to that date is optional.

How do fellows get an ID and password to access the ACGME Case Log System?

New fellows will have an ID and password assigned and emailed to them when their information is first entered into the ACGME's Accreditation Data System (ADS) by their program director or coordinator. For fellows who were in the program prior to the Case Log application, program directors or coordinators should go to the Fellow Roster in ADS and click on "Grant User." This will create and email IDs and passwords to existing fellows. In either case, fellows will be required to change their passwords the first time they log into the system.

Can the program director and coordinator access the ACGME Case Log System?

Yes. Program directors and coordinators can access the system in a "view only" mode. In ADS, go to **Case Logs > Cases > Entry (View Only)**. Information can be entered but not saved.

Can fellows log procedures that are not being tracked in the ACGME Case Log System?

Fellows are only required to log those experiences the Review Committee is tracking (see previous page). However, programs and/or fellows may use the system to track other procedures for their own purposes.

Can a program receive a citation based on ACGME Case Log data?

The Review Committee will begin issuing citations regarding the number of fellows' procedural experiences after June 30, 2025. Areas for improvement may be given prior to this date.
